



NOMINATIONS FOR THE ENTERPRISE CHAMBER BOARD OF DIRECTORS

The Nominating Committee is currently accepting nominations for the 2026 Enterprise Chamber of Commerce Board of Directors. Nominations are open to all current Chamber members, including representatives of member businesses, community organizations, individual members, and self-nominations.

Serving on the Enterprise Chamber Board of Directors is an opportunity to make a meaningful impact on the future of our community while growing personally and professionally as a leader. Board members are respected business and community leaders who bring diverse perspectives, industry expertise, valuable skills, and a shared commitment to strengthening our local economy and enhancing quality of life in the Enterprise area.

Directors play an important role in shaping the Chamber's vision, programs, advocacy efforts, and long-term strategic initiatives. In addition to governance responsibilities, Board members serve as ambassadors for the Chamber and the Enterprise community by supporting local business growth, community engagement, and initiatives that contribute to the continued success of our area.

Board members are elected to serve a three (3) year term, unless elected to fulfill an unexpired vacancy, providing opportunities for leadership development, professional networking, and increased community involvement and visibility.

Board Member Expectations & Requirements

Board members are expected to actively support the mission and work of the Chamber through participation, leadership, and advocacy.

To be eligible for service, nominees should:

1. Be a current Chamber member in good standing, or an employee/representative of a member business or organization in good standing for at least one (1) year.
2. Be able to attend a minimum of nine (9) monthly Board meetings annually.
3. Participate in Board Orientation.
4. Serve on at least one (1) Chamber committee or task force each year.
5. Attend a minimum of ten (10) Chamber-sponsored events or functions annually.
6. Support the Chamber's short-term and long-term strategic goals and initiatives.
7. Assist with membership recruitment, retention, and engagement efforts.
8. Support organizational fundraising and sponsorship efforts through direct sponsorship participation or sponsorship outreach.

Nomination Process

1. Nominations will be accepted from May 15 – June 30, 2026.
2. All nominations must be submitted using official Chamber nomination forms.
3. Nominees must approve their nomination prior to submission.
4. The Nominating Committee will review all submissions and present recommendations to the Board of Directors in July.
5. Selected nominees will be contacted by the Chamber in August and formally introduced at the Annual Membership Meeting & Awards Banquet in September.
6. Board terms will begin October 1, 2026.
