Nomination Deadline: October 15, 2025

The City of Enterprise, Alabama—proudly recognized for its spirit of Progress and Patriotism—honors the remarkable contributions of local veterans, active-duty service members, and their families. Their unwavering dedication, leadership, and selfless service inspire others and play a vital role in strengthening the fabric of our community. The Service Member of the Year Award, presented by the City of Enterprise and the Enterprise Chamber of Commerce Military & Veterans Affairs Committee, celebrates those who exemplify excellence in military service, leadership, and volunteerism both in uniform and in their civilian lives. The award will be formally presented at the Veterans Appreciation Community Luncheon on Thursday, November 6, 2025

## **Eligibility Criteria**

Nominees must meet the following criteria to be considered eligible:

- 1. Reside in the City of Enterprise, Coffee County, or Ft. Rucker area.
- 2. Be active military service, (Army, Air Force, Navy, Marines, Coast Guard and Space Force) or active duty (National Guard and Reserves).
- 3. Not have previously received this award.
- 4. The nominee must be available to attend the Veterans Appreciation Community Luncheon on Thursday, November 6, 2025, from 11:30 AM 1:00 PM at the Enterprise Civic Center.

Additional Consideration will be given to nominees who:

- 1. Actively participate in an Enterprise-based Veteran Service Organization(s) and/or other local community organization(s).
- 2. Have made notable volunteer contributions supporting veterans or the military community between October 1, 2024 September 30, 2025.
- 3. Have earned recognition at the local, state, or national level during the same period.

## **Nomination Requirements**

- 1. Submit the completed nomination form and all required materials by 4 PM on Wednesday, October 15, 2025.
- 2. Provide a current and legible Soldier Record Brief (or equivalent).
  - o All personal identifying information (PII) must be redacted.
  - \*\*This information will be kept confidential and destroyed or returned upon review and verification.
- 3. Provide a brief biography and written summary detailing the nominee's contributions during the award period. Include any of the details below accomplished within the period (2 page maximum):
  - Notable accomplishments, including dates and supporting documentation (e.g., news articles, commendations, online bios).
  - List of active involvement in Veteran Service Organizations and/or Civic/Community Groups in the Enterprise area.
  - Details of volunteer service to veterans and community programs (e.g., church, youth, school, civic engagement).
  - o List of any awards or achievements received in the past 12 months.
  - o If employed, description of job responsibilities and contributions beyond expectations.
  - A clear statement explaining why the nominee deserves this award.

#### **Selection Process**

Nominations will be reviewed and scored by a veteran-led subcommittee from outside the Enterprise area. Evaluations will be based on the nominee's impact and involvement in veteran-service activities, community involvement, and leadership during the during the award period.

Please provide specific and detailed examples of your nominee's service. All materials provided with your nomination will be carefully and thoughtfully reviewed by the selection committee. \*Remember - Your narrative helps them understand the scope and impact of the nominee's service.

## Nominees will be scored in the following areas:

- Verification of Active Military Service or Active Duty
- Participation in Veteran Service Organizations or Veteran-Focused Community Outreach Programs
- Participation in general community and civic organizations
- Documented Veteran Support Activities and Civic/Community Service Activities
- Recognition of leadership and/or service at local, state, or national level, including documented awards or achievements in the past 12 months
- Biography/Written Summary
